

Divert- Frequently Asked Questions

Product Name: Divert Insecticide and Repellent

EPA Registration Number: This 25(b) product is exempt from registration with the Federal Environmental Protection Agency under FIFRA regulations.

Formulation: Ready to Use

Active Ingredient and Percent Included: Geranoil 3.7% Thyme Oil 4.0%

Package Sizes: Spray bottle 32 fl. oz

Use Restrictions:

- Do not smoke while applying this product.
- Use precautionary measures to ensure that there is no direct exposure to humans, pets, domestic animals or non-target wildlife.
- Do not apply directly to plants to avoid damage or discoloration.
- Do not apply to the point of drench.
- Avoid contact with eyes

AUTOMATED USE RESTRICTIONS: NA

APPLICATION DIRECTIONS: Simply aim and spray.

Spray directly on insects. Spray on trails, nests, and paths that insects take. Focusing on crevices, spray around appliances, under cabinets, along baseboards, along door and window frames and sills. For drain flies, spray inside and outside of drains. Spray outside and inside walls, floors, openings, HVAC intakes and sideboards of mushroom houses.

Do not spray directly on mushrooms or mushroom growing media. Also spray over the plastic covering mushroom beds and trays after spawning. Treated surfaces may be slippery when wet.

Do not spray compost or casing.

How long after application can I re-enter the site?

Immediately - There are no re-entry restrictions.

How long after application can I harvest or eat the crop?

Immediately

What pests does it control?

For the control of flies, fruit flies, drain flies, roaches, ants, dust mites, spiders, bed bugs, millipedes, crickets and many other insects.

What pests does it not control?

Birds, rodents and other mammals

Where can I apply it?

For use around mushroom production facilities, processing plants and warehouses, waste and refuse areas such as collection areas, landfills and transfer stations, etc.

What are the use rates? Ready to use, simply point and spray.

Indoor Applications: Ready to use, No mixing

Outdoor Applications: Ready to use, No mixing

When should I apply it? Apply prior to pest invasion and whenever pests are present.

Who can use it? Anyone, you do not have to be a certified applicator

Why use it? To repel and kill insects and pests

How does it work?

When sprayed directly on the pest Divert causes damage to the body of the insect resulting in death.

When insect resting and entry areas are sprayed, such as doorframes, window casements etc., Divert repels the pests by making them dizzy and sick resulting in the pest leaving the area.

How do I apply it?

Spray areas where insect pests enter and leave buildings and other structures such as doors, windows as well as places they prefer to land or rest such as corners, walls etc.

Keys to success:

Pests must have the ability to leave the treated area. If pests are trapped in treated area they will migrate to areas with limited air flow.

Where does it not work? Divert does not work in large open areas

Special Features/ Warnings

Divert should not be sprayed on plants as it will result in damage or loss of foliage.
